

## Release, Waiver, Indemnification, and Assumption of Risk Agreement

This release, waiver, indemnification, and assumption of risk agreement (hereafter "Agreement") dated as of the date set forth below, is by and between the undersigned (hereafter "Parent") and Play Like a Girl.

- 1. Parent is the parent or legal guardian of \_\_\_\_\_\_ (hereafter "Student"), who intends to enroll or is enrolled as a Play Like a Girl Student Ambassador.
- 2. Parent understands that Student will engage in educational and extracurricular activities while participating in the Student Ambassador Program at Play Like a Girl, including physical indoor and outdoor activities and events. Parent further understands that there are hazards involved in Student's participation in such activities, including, but not limited to serious injury.
- 3. Parent desires to permit Student to engage in all activities provided or scheduled by Play Like a Girl with full knowledge of the inherent risks and dangers and the physical injuries that could result, and hereby agrees to assume the risk of any such injury.
- 4. Play Like a Girl assumes no responsibility for damage to or theft of personal property of Student or Parent which may occur in connection with student's enrollment at Play Like a Girl.
- 5. Play Like a Girl may take photos or video of your child for use in training and promotion, including but not limited to school flyers, newspaper advertisements, television and website use.
- 6. Play Like a Girl will not permit any student to participate in its programs or activities prior to the execution of the Agreement by Student's Parent or legal guardian.

In consideration of Student's enrollment at Play Like a Girl and Student's ability to participate in programs and activities of Play Like a Girl, Parent agrees as follows:

- 1. Parent agrees that if Student has any health problems such as heart, respiratory, or circulatory conditions, diabetes, or epilepsy, she or he will so inform Play Like a Girl prior to executing this Agreement.
- 2. Parent hereby releases, waives, discharges, and relinquishes any and all claims or causes of action for personal injury, property damage, or theft which may arise as a result of Student's enrollment in the Student Ambassador Program at Play Like a Girl.
- 3. Parent for her/himself and on behalf of Student, their respective heirs, agents, personal representatives and assigns, agrees that in the event any claim for personal injury, theft, or property damage arising from student's enrollment at Play Like a Girl shall be prosecuted against Play Like a Girl, Parent shall indemnify and hold harmless Play Like a Girl from any and all such claims or causes of action by whomever or wherever made or presented.
- 4. By signing below, Parent agrees to the terms of this Agreement for her/himself and on behalf of Student, and waives any derivative cause of action that such parent or guardian may otherwise have had as a result of personal injury or death of Student.
- 5. As used herein, "Play Like a Girl" shall include the business entity, its officers, directors, employees, agents and servants.
- 6. As used herein, "enrollment" at Play Like a Girl shall include participation in any and all programs, events and activities conducted, offered or sponsored by Play Like a Girl, including on-site and off-site programs, events and activities.

IT IS THE INTENTION OF PARENT BY SIGNING THIS AGREEMENT TO EXEMPT AND RELIEVE Play Like a Girl FROM ANY LIABILITY FOR PERSONAL INJURY, THEFT, OR PROPERTY DAMAGE.

Parent acknowledges that he/she has read the foregoing, fully and completely understands the potential dangers incident to Student's enrollment, and is fully aware of the legal consequences of signing this Agreement.
